 - 3 team members on the audits; one for HTA and two for HCAOG and other entities. A good estimate of the amount of time needed for three fiscal years would be about 350 hours.
- How many audit hours did your current auditors propose under your existing contract?
 - o 410 hours for three fiscal years however they did close our books as well, which we will not need from a new auditor.
- What were the prior year's total audit fees, and can you provide the breakdown by components?
 - The contract for three fiscal years had a not to exceed amount of \$167,500. The most recent fiscal year's audit fees were \$57,500 and \$2,500 for single audit.
- Are there any significant changes in operations expected for FY 2024-25?
 - o No
- Were there any significant events in 2023-24? Will there be any significant events in FY 2024-25?
 - o No
- Have there been any changes in your accounting system since last year or any planned changes in the future?
 - o No. We have used and plan to keep using QuickBooks.

 - o HCAOG does not have any bond issues and do not plan to have any in the future.

 - HCAOG has one lease for our office building and 7 subscriptions included in our Enterprise System Catalog.

 - o None

 - Yes. The previous Fiscal Administrative Officer retired in December 2023 after 24 years. The new Administrative Services Officer has been in her role since April 2023. The Executive Director also resigned in December 2024 and a new Executive Director will be hired this quarter.

 - There are issues with some of the agencies not submitting information to auditor in a timely manner leading to the need for an extension from the SCO.
- What efficiencies would you like to see in the audit of the HCAOG's financials?
 - We would like to be able to submit audits to the SCO on time.
- Will digital proposals be accepted in lieu of hard copies?
 - o Yes, digital proposals are preferred.
- When are the books of HCAOG and HTA closed and ready for audit?
 - HCAOG books close approximately two months after the end of the fiscal year.
 HTA typically takes longer because they have an outside auditor that they depend on to close their books.
- Were any extensions requested for the 6/30/24 year end? If so, which agencies were extensions requested for?
 - Yes. Arcata and HTA were unable to provide information within the deadline and an extension was requested from the SCO.

 - O Document insurance is a type of coverage that protects against the loss, theft, or damage of important documents, such as legal papers, business records, contracts, and financial statements. It is often included in broader business insurance policies or as part of professional liability insurance for industries that handle sensitive paperwork.

 - HCAOG would accept either type of contract but both would need a not to exceed amount.

 - o The contract for three fiscal years had a not to exceed amount of \$167,500. The most recent fiscal year's audit fees were \$57,500 and \$2,500 for single audit.
- Do you anticipate the audits being performed remotely or on-site? If on-site fieldwork is requested, can you clarify which agencies would have on-site fieldwork?
 - o HCAOG would accept either option, but remote is preferred.
