RESOLUTION OF THE HUMBOLDT COUNTY ASSOCIATION OF GOVERNMENTS
ADOPTING THE FY 2024-25 STATE TRANSIT ASSISTANCE
PROGRAM OF PROJECTS

WHEREAS, the California State Controller published the Fiscal Year 2024-25 State Transit Assistance (STA) Allocation estimate; and

WHEREAS, Humboldt County Association of Governments (HCAOG), in its official capacity as the Regional Transportation Planning Agency, is required to allocate these funds to STA-eligible operators in the Humboldt region; and

WHEREAS, the California State Controller has estimated \$1,602,952 of regional 99313 and \$267,839 of 99314 for a total of \$1,870,791 of STA funds for FY 2024-25; and

WHEREAS, HCAOG solicited regional projects and received the following project requests:

WHEREAS, operators are required to submit certifications, completed within the last 13 months by the Department of the California Highway Patrol, verifying compliance with section 1808.1 of the Vehicle Code, as required in Public Utilities Code section 99251; and

WHEREAS, payments will be made upon approval of claims accompanied by invoices as funding become available.

NOW, THEREFORE, BE IT RESOLVED that HCAOG approves the allocation State Transit Assistance Funds for FY 2024-25 up to the amounts indicated in this resolution:
