Staff Summary:

The next Unmet Transit Needs (UTN) cycle is for the Fiscal Year 2024-25. The draft timeline for the Unmet Transit Needs process is included in this staff report for discussion. As the SSTAC leads the UTN process, the Council is invited to provide additional direction to staff regarding public outreach methods and UTN report content at this meeting.

The timeline includes adopting revised TDA Rules and Regulations in order to update the 'reasonable to meet' criteria as discussed further in the Performance Audit Recommendations staff report. Staff would make the minor update to the TDA Rules and bring for approval to the HCAOG Board in September, which would allow time for the UTN Synopsis that accompanies the public hearings to be updated with the new standard.

The SSTAC is asked to review and move to approve the below FY 2024-25 UTN timeline.
